- Food Minimum: \$450.00
- Total: \$1340.00 + Capital Assessment Fee

SOCIAL FAMILY MEMBERSHIP:

Unlimited use of clubhouse and pool facilities for individual, spouse, or dependent children. Social Members will be permitted to play golf four times per year paying green fees. Participation in club tournaments is not permitted unless designated and advertised to membership by the Golf Professional.

- Dues: \$1,510.00
- Food Minimum: \$900.00
- Total: \$2410.00 + Capital Assessment Fee

GOLF SINGLE MEMBERSHIP:

Unlimited golfing privileges and use of locker, bag storage, clubhouse, and pool facilities for unmarried individual or dependent children.

- Dues: \$2,785.00
- Food Minimum: \$450.00
- Total: \$3235.00 + Capital Assessment Fee

GOLF FAMILY MEMBERSHIP:

Unlimited golfing privileges and use of locker, bag storage, clubhouse, and pool facilities for individual, spouse, or dependent children.

- Dues: \$3,340.00
- Food Minimum: \$900.00
- Total: \$4240.00 + Capital Assessment Fee

NON-RESIDENT MEMBERSHIP:

Permanent residence must be beyond a 40-mile radius (call SVCC for details).

- Dues: \$400.00

POOL MEMBERSHIP:

Unlimited use of pool and pool facilities for individual, spouse, or dependent children (not previous members of SVCC). Six complimentary guest passes will be issued per year (additional passes \$5.00 each), use of the clubhouse facilities (Memorial Day—Labor Day).

- Dues: \$350.00

BUSINESS MEMBERSHIP:

Designate four company employees (not previous members of SVCC), corporate account, \$40.00 greens fees—unlimited weekday use of golf facilities, unlimited use of clubhouse facilities, with no voting rights.

- Dues: \$850.00
- Food Minimum: \$850.00
- Total: \$1700.00 + Capital Assessment Fee

CAPITAL ASSESSMENT FEES: \$20.00/\$40.00 Monthly (Non-Resident, Pool Excluded)
