GOLF FAMILY MEMBERSHIP:

Unlimited golfing privileges and use of locker, bag storage, clubhouse and pool facilities for individual, spouse, or dependent children.

- **Dues:** \$3,180.00
- **Food Minimum:** \$700.00
- **Monthly Investment:** \$323.33

GOLF SINGLE MEMBERSHIP:

Unlimited golfing privileges and use of locker, bag storage, clubhouse and pool facilities for unmarried individual or dependent children.

- **Dues:** \$2,650.00
- **Food Minimum:** \$350.00
- **Monthly Investment:** \$250.00

SOCIAL FAMILY MEMBERSHIP:

Unlimited use of clubhouse and pool facilities for individual, spouse, or dependent children. Social Members will be permitted to play golf four times per year paying green fees. Participation in club tournaments is not permitted unless designated and advertised to membership by the Golf Professional.

- **Dues:** \$1,435.00
- **Food Minimum:** \$700.00
- **Monthly Investment:** \$177.91

SOCIAL SINGLE MEMBERSHIP:

Unlimited use of clubhouse and pool facilities for individual or dependent children. Social Members will be permitted to play golf four times per year paying green fees. Participation in club tournaments is not permitted unless designated and advertised to membership by the Golf Professional.

- **Dues:** \$845.00
- **Food Minimum:** \$350.00
- **Monthly Investment:** \$99.58

ASSOCIATE MEMBERSHIP:

An Associate discount is provided to persons ages 21 to 29. Associate memberships are characterized by a golf or social membership. Members ages 21 to 29 are not entitled to voting privileges (see bylaws).

POOL MEMBERSHIP:

Unlimited use of pool and pool facilities for individual, spouse, or dependent children (not previous members of SVCC). Six complimentary guest passes will be issued per year (additional passes \$5.00 each), use of the clubhouse facilities (Memorial Day—Labor Day).

- **Dues:** \$350.00
- **Food Minimum:** \$180.00

BUSINESS MEMBERSHIP:

Designate four company employees (not previous members of SVCC), corporate account, \$40.00 greens fees—unlimited weekday use of golf facilities, unlimited use of clubhouse facilities, with no voting rights.

- **Dues:** \$845.00
- **Food Minimum:** \$700.00

NON-RESIDENT MEMBERSHIP:

Permanent residence must be beyond a 40-mile radius (call SVCC for details).

- **Dues:** \$400.00

MEMBERSHIP APPLICATION FEE: \$100.00 (Pool Membership Excluded)

CAPITAL ASSESSMENT FEES: \$15.00/30.00 Monthly (Pool, Non-Resident Excluded)
