- **Dues:** \$1,990.00
- **Food Minimum:** \$900.00
- **Total:** \$2,890.00

SINGLE SENIOR SOCIAL MEMBERSHIP:

Members over the age of 75 have unlimited use of clubhouse and pool facilities for individual or dependent children. Social Members will be permitted to play golf **four** times per year paying green fees. Participation in club tournaments is not permitted unless designated and advertised to membership by the Golf Professional.

- **Dues:** \$500.00
- **Food Minimum:** \$450.00
- **Total:** \$950.00

SINGLE GOLF MEMBERSHIP:

Unlimited golfing privileges and use of locker, bag storage, clubhouse, and pool facilities for unmarried individual or dependent children.

- **Dues:** \$2,650.00
- **Food Minimum:** \$450.00
- **Total:** \$3,100.00

FAMILY GOLF MEMBERSHIP:

Unlimited golfing privileges and use of locker, bag storage, clubhouse, and pool facilities for individual, spouse, or dependent children.

- **Dues:** \$3,820.00
- **Food Minimum:** \$900.00
- **Total:** \$4,720.00

ASSOCIATE MEMBERSHIP:

An Associate discount is provided to persons ages 21 to 29. Associate memberships are characterized by a golf or social membership. Members ages 21 to 34 are not entitled to voting privileges (see By-Laws).

- **Dues:** \$350.00

BUSINESS MEMBERSHIP:

Designate four company employees (not previous members of SVCC), corporate account, \$40.00 greens fees—unlimited use of golf facilities and tournament eligible, unlimited use of clubhouse facilities, with two free room rentals for corporate meetings.

- **Food Minimum:** \$1,200.00
- **Total:** \$2,400.00
